Our relationship with partner, Eastern Community and Technical College, grew into formation of the Potomac Highlands Creative Economy initiative—a forum of information sharing, convened regularly by AFNHA—to elevate sustained and appropriate economic development in a large segment of our 18-counties catchment area in West Virginia and western Maryland.

Yet another key happening was the gracious award of a substantial grant for economic development in the region by the Benedum Foundation.

The continuing and increasingly productive working relationship with our consulting firm, Point Heritage Development Consulting, has helped focus our organizational goals and methods, to be implemented over the next several years.

Management Planning



In March 2019, Appalachian Forest Heritage Area was designated a National Heritage Area with 3 years to develop our Management Plan. The plan will need extensive public input to shape how we best serve our 18-county region in West Virginia and western Maryland. The first year was spent getting funding in place, and selecting our consultant team, Point Heritage Development Consultants. The second year focused on extensive virtual public and task group meetings, along with extensive travel with our consultant team and 2021 would see the actual drafting of our the completed Management Plan for designation, to be turned in to the NPS my mid- 2022.

2021 was a big year for AFNHA Management Planning, led by our consultant team Point Heritage Development Consultants, working in partnership with AFNHA staff and board. The team conducted interviews, research, and 10 planning meeting events, most virtually, including public meeting and stakeholder task groups. We completed a situational analysis, revision of themes and mission, and received input towards goals and priorities. New goals were drafted to better fit the newly revised mission of AFNHA, all with extensive public input from task groups and public meetings.

All these tasks came to fruition at the public, in-person Exchange Camp held at 4H Camp Pioneer in late July. Here, over 75 community partners, stakeholders, and participants gave feedback in 8 different sessions created to touch base on all topics important to the future work of AFNHA. These topics were: Arts, Culture and Traditions, Historic Preservation, Visitor Experience, Natural Resources, Outdoor Recreation, Community Development, Interpretation and Education, and the Partnerships/Communications Network.

Using these notes and feedback, we hosted a final group of public meetings to present findings and garner feedback on consultant suggestions. Now the plan goes to the Point Hertiage team, to craft the Management Plan that will be presented to the NPS and Congress. Then the Point Heritage team started work on drafting the plan that will be submitted mid-2022.

Thank you to all who participated in the Organization Structure/Management, Interpretation/Visitor Experience, and the Asset Stewardship/Enhancement task groups, along with all the sub-groups! The input we received from YOU was vital in revising our mission statement, goals for the organization, our interpretive themes, and much more! We owe you a debt of gratitude, and hope you continue to stay involved in AFNHA and our bright future. Thank you!

"During my time on AFNHA's Pollinator Initiative, I had the opportunity to create and run the first pollinator conservation conference in the Appalachian Forest Region, bring on eight official Pollinator Initiative partners, and plan and install a native pollinator garden with interpretive signage in a community park. This position gave me the opportunity to take the lead on a range of projects and bring my own vision for pollinator conservation to life, something I would not have been able to do elsewhere. Additionally, AFNHA's AmeriCorps program provides the unique chance to receive service hours assisting other AmeriCorps members in the program. 2021 was a successful year for the AmeriCorps program! All the members continued to navigate a world shook by COVID-19 but still found ways to succeed! Outdoor projects and community development returned in full force! 27 members continued to serve from January to August 2021. We welcomed 24 new members in September 2021 with 12 returning members for a total 36 members !

Conservation Members improved 695 acres of land through tree plantings, removing invasive species, and restoring watersheds, plus monitored conditions on 9,208 acres. Environmental outreach and education reached over 1,930 youth and 8,550 adults. Community Development Members accomplished local community projects and enhanced cultural heritage tourism exhibits, programs, and events for museums, historic sites, and arts organizations. Members provided services to around 50,035 community members through public (25%) and online outreach (75%). (Online engagement was heavy in 2021 due to the pandemic.)

In 2021, project staff continued work to develop Monongahela Outdoor Volunteers under the ARC technical assistance grant "Creating a Sustainable Volunteer Trail Maintenance Program: A Key Requirement for Achieving Economic Development through Recreational Tourism". Accomplishments for the year included completion of a business plan detailing programs designed to help communities around the Monongahela National Forest (MNF) transition to and sustainably support a trail-based recreation economy, with an initial focus on the Gauley Ranger District. The plan covers both startup and sustainability phases with two interdependent programs aimed at both preparing trail infrastructure for visitors (the trail maintenance program) and preparing local communities for success in a trail-based recreation economy (the "Volunteers-to-Careers" program). Additionally, staff completed trail work inventories to inform future projects and organized several pilot volunteer outings to identify lessons learned as well as cross-cutting themes to guide development of the volunteer component of the trail maintenance program during implementation. Through SRS RAC support, MOV obtained a sawyer and assistant and maintained 60 miles of trails in the Gauley Ranger District, with a special emphasis on clearing and restoring two popular trails that had not received significant maintenance over the past several years (Cowpasture and Kennison Mountain Trails). The group additionally secured funding for tools and equipment to support future volunteer trail work.


In the upcoming year, MOV staff will continue its efforts to grow local volunteerism and increase trail use to improve the level of readiness for implementation. The group will continue progress on improving the user experience on the 60 miles of trails currently advertised for mountain biking and hiking and will work to improve marketing of gravel biking resources. To inform future improvements in the Cranberry Wilderness area, they will complete additional trail work inventories. Additionally, MOV leadership will work to increase stakeholder understanding of requirements for sustaining trail-based recreation, informed by a readiness assessment completed as part of planning activities.

Highlands Creative Economy



AFNHA received a grant award from the Benedum Foundation for \$150,000 to continue and expand the Highlands Creative Economy group to the entirety of the 18county AFNHA region in West Virginia and eastern Maryland. In partnership with Eastern WV Community and Technical College, this project works to grow tourism and improve communities in the region and grow networking opportunities' for all!

In 2021 we hosted 8 Highlands Creative Economy Meetings, and our average attendance was 35, with 144 individuals and organizations on our mailing list. The 2021 Tourism Summit, hosted virtually, attracted over 75 attendees. AFNHA launched the first ever Tourism Development mini-Grant, spearheaded and funded from the creative economy efforts. Awards for the grant will come in 2022!

The Highlands Creative Economy group meets monthly and is open to tourism attractions, businesses, and service providers. 
Due to the severity of declines in pollinator species abundance, it is critical to expand efforts and take new steps to reverse local pollinator losses, restore populations, and improve habitats. In 2021, AFNHA received 10 new pledges to support pollinators in our region! These came from the City of Elkins, Appalachian Headwaters, the City of Frostburg, the City of Philippi, the Town of Cowen, the City of Oakland, the US Fish and Wildlife Service, the Beverly Heritage Center, Green Forest Works, and the Town of Mountain Lake Park. 
